Unfinished Business

Tournament Schedule:

- 1) Randahl Holder has finalized the major tournament schedule, and it is posted on the website, and he has emailed it to the board.
- 2) Tournament set-ups and rules were discussed at length until a consensus was reached for the opener. See Upcoming Events and Tournament Committee report.
- 3) Randahl Holder will send out the Opener sign up email to the members 2 weeks prior to the start of the Season. He will also send out an email about the Match Play events.

New Business

Dave Sanders will send out a survey to the members via Member Planet. Aaron Zick will write some questions regarding members' opinions and thought/wants about the club. All board members are invited to submit questions to be included in the survey.

Upcoming Events:

The Spring Opener (March 14th):

The following are the set-up and rules Randahl has submitted for the Spring Opener event that were approved by the Tournament Committee by a majority vote:

- 1) Stroke Play – Gross and Net with a \$40 entry fee (includes KP's and Skins).
- 2) 3 Tees – Blue, White and White/Gold combo.
- 3) Players will choose the Tees they want to play at sign-up.
- 4) Players can choose their foursome.
- 5) The payout will be a 30-70 split for gross and net paying 33% of the field.
- 6) Shotgun start at 9 am with meeting afterward. Lunch and 1 drink ticket included.

Officer Reports

President: Aaron Zick reported that he has been working with Randahl Holder on event set-ups.

Vice President: Chris Underwood reported that all the trophies and the Master's jacket are back and in the trophy case. He is working on getting names of all members who have passed away in the last year.

Treasurer: Scott Carver reported that he is continuing to work on the budget for the 2026 season. It is based on the previous year's budget, and it can and probably will be adjusted as the year goes on. He will email it to the board when it is finalized.

Tournament Director: Randahl Holder reported that he has been working on tournament set-ups with. The tournament set-ups are discussed in New Business. Randahl also reported that he has been talking with people from the OGA about how their tournament flights are set-up. They create groups within flights for players that opt to change tees.

Handicap Director: Dave Sanders reported that we currently have 261 members signed up. 181 of those signed up using Member Planet and 80 sign up the traditional way.

Secretary: Mike Rusch did not have anything to report.

At Large Member: Kieth Rist did not have anything to report.

At Large Member: Mike Sly did not have anything to report, but states he would like to work on more club advertising in the future.

Committee Reports

Tournament Committee: The board discussed option going forward for Tournament set-ups. The following are the set-up and rules agreed upon for the Spring Opener:

- 1) Individual Stroke, Gross and Net.
- 2) Players will be allowed to choose the tee they want to play. Blue, White or White/Gold.
- 3) 33% of the field will be paid.
- 4) 70/30% for the Blue and White flights. White/Gold will be 100% net.
- 5) Flights will be broken into groups depending on the number of players who sign up.
Base on previous years, most likely there will be only 1 blue flight, about 20-25 players.

White flight, usually about 60-80 players, will be broken into even number of players.
So, 60 players will be 2 groups of 30, and 75 will be 3 groups of 25 etc.

- 6) KPs and skins for each Flight.
- 7) Choose the players in your group.

Handicap Committee: No report.
